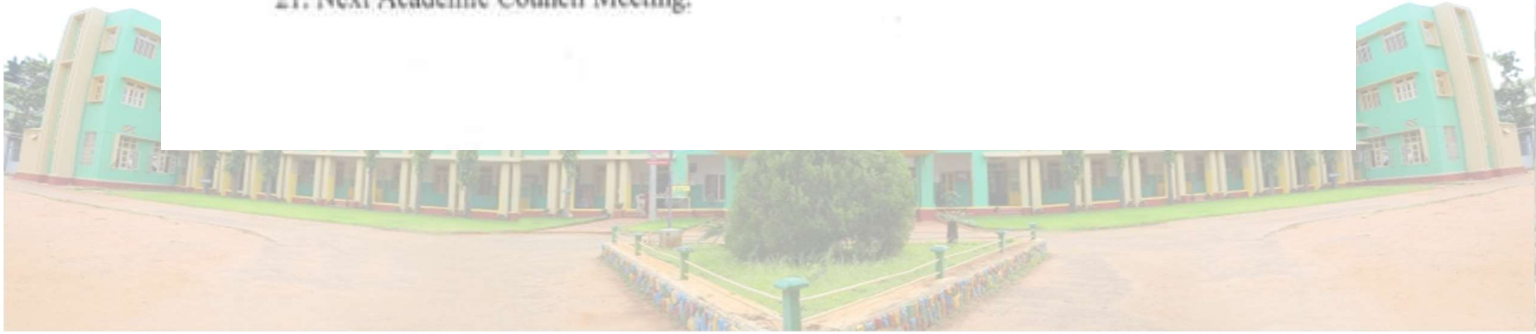

### **Welcome Address**

The Secretary of the College, Dr. Sr. Gerardin Jayam, welcomed the members. The members of the board, were called upon to introduce themselves to the council members.

### **Chair Person's Address**

The Principal Dr. Sr. Anne Perpet Sophy, addressed the council,briefing on the history of the institution, adding a note on the current strength of staff and students. She also highlightedon the activities that have been conducted throughout the academic year for the benefit of the students, like Graduation Day, Sports Day, Fine Arts Celebrations, etc.

She expressed her gratitude to the faculty, the support staff and the students who had cooperated and put in draconian efforts for the successful completion of the 4<sup>th</sup> cycle of the NAAC Accreditation of the college,which won an 'A+' Grade with CGPA 3.35. She also appreciated the efforts that were put in by our faculty members, towards ARIIA and NIRF ranking and the establishment of IIC to motivatethe innovative and entrepreneurial skills of students, to overcome the job crisis.

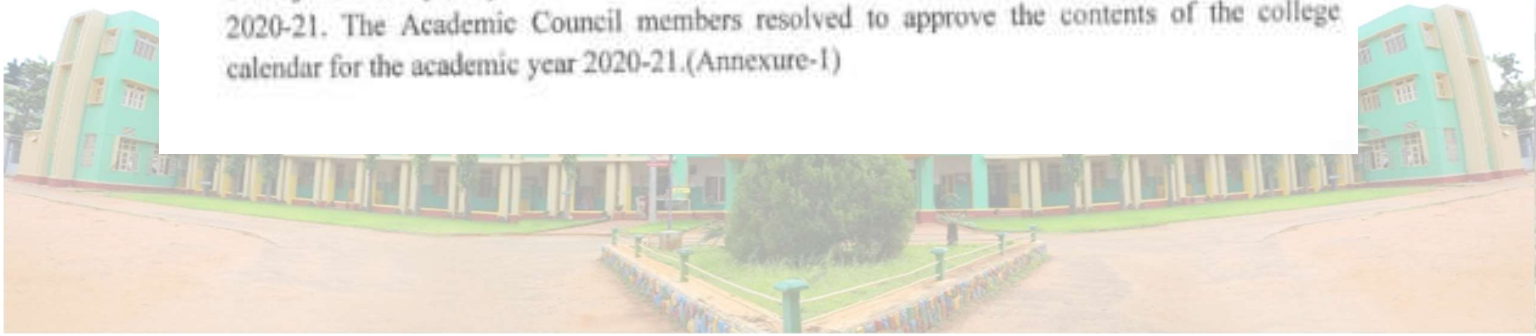

### **Item 01/AC 20.02/ 04: Approval of the Minutes of the previous meeting**

The Principal, Dr.Sr. Anne Perpet Sophy, invited the Dean of Arts, Dr.Alby Grace to present the minutes of the previous meeting held on 25.2.2019.The detailed report was read and approved by the Council.

### **Item 02/AC 20.02/ 05: Approval of the College Calendar for the Academic Year 2020-21**

Dr. Ajith Sindhuja,Dept. of Chemistry, presented the college calendar for the academic year 2020-21. The Academic Council members resolved to approve the contents of the college calendar for the academic year 2020-21.(Annexure-1)



**Item 03/AC 20.02/ 06: Restructuring of Curriculum**

It was resolved to accept the revised course structure for UG and PG programme with the inclusion of a course on 'Community Engagement Course' introduced by UGC with 30 hours and 2 credits.

The number of credits for Part I and Part II for each course in UG programme were increased from 3 to 4. The number of credits for Core, Allied and Elective papers were also changed. Total required credits for UG Students will be 145 and for PG Students will be 92 excluding the credits for extra credit courses.

The curriculum structure for M.Phil. has not been changed (credits-30) since changes have been brought about only during the last year.

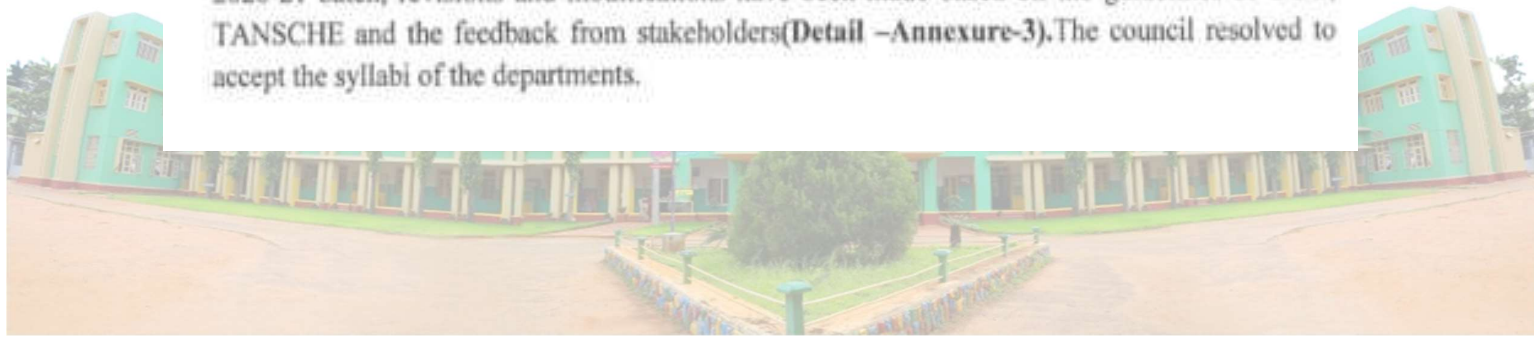

The Heads of all Departments presented their revised syllabus along with PSOs and Course outcomes. They also mentioned the relevance of the courses for local, national, global needs, environmental sustainability, Human values and professional ethics in the revised syllabus for I and II semester courses of UG and PG. In the restructuring of the courses for the students of 2020-21 batch, revisions and modifications have been made based on the guidelines of UGC, TANSICHE and the feedback from stakeholders (Detail -Annexure-3). The council resolved to accept the syllabi of the departments.



**Item 05/AC 20.02/08: Ratifications**

The members resolved to accept the following ratifications.

- **Department of Physics and Chemistry:** In UG Program, one of the elective courses was changed into project.
- **Department of Physics, Commerce and Economics:** Individual project was suggested instead of group project for PG.

**Office of the Controller of Examinations:**The CoE presented the ratifications proposed by the Award Committee. Discussions on the ratification for the conduct of two Formative Assessments instead of three were taken up. The chairpersons represented the problems associated with the conduct of 2 Formative Assessments instead of three. It was resolved that students who have missed one of the Formative Assessments due to genuine reasons, can appear for the exam within 10 days on special appeal through the concerned in-charges.

**Item 06/AC 20.02/09: Approval of Panel of Examiners for UG, PG and M.Phil. Programmes (Annexure-4)**

The panel of examiners were presented by the CoE. The university nominees suggested to have some examiners from outside Manonmaniam Sundaranar University, Tirunelveli. As of now, it was resolved to approve the panel of examiners for UG, PG and M.Phil. Programmes and the CoEs authorized to invite the members for the theory and practical examinations of various Departments.

**Item 07/AC 20.02/10: Approval of the distribution of marks for the formative and summative examinations (Annexure-5).**

The Controller of Examinations presented the new pattern of assessment for the internal and external components of the question pattern for UG, PG and M.Phil. Programmes. It was resolved by the academic council to approve the distribution of marks for the internal and external components of the question pattern of UG , PG and M.Phil. Examinations.

**Item 08/AC 20.02/ 11: Outcome Based Education**

The Controller of Examinations presented the procedures followed in the implementation of OBE for PG programmes. OBE is implemented through myclassroom.com. The CoE also mentioned that OBE will be implemented for the I UG students from the academic year 2020-21. The Academic council members appreciated the new ventures and approved the recommendations put forth by the CoE.



**Item 09/AC 20.02/ 12: Result analysis**

The Controller of Examinations presented the result analysis of the even semester examinations held in April-May 2019 and the odd semester examinations held in Oct-Nov.2019(Annexure-6). It was resolved to accept the decisions of the award committee meetings held in May 2019 and Dec 2019.

**Item 10/AC 20.02/ 13:Awards and achievements(Annexure-7)**

The Physical Directress Dr. J. Christy Colin Mary and the Chair persons of the departments of English, Botany, Chemistry, Physics and Social Work presented the awards and achievements of the students of their Departments. The students who have cleared NET this year and those who were selected for the Summer Research Fellowship of the Indian Science Academies' were specially mentioned with great appreciation.

**Item 11/AC 20.02/ 14: Innovative programs/ quality initiatives (Annexure-8)**

The Heads of the departments presented the new measures / quality initiatives that are to be adopted in the department from the academic year 2020-21 onwards and it was accepted by the Academic Council.

**Item 12/AC 20.02/ 15:Guidelines for awarding credits for Online and Value Added Courses**

The Dean of Science presented the details regarding the online and value added courses. The Academic council approved to offer 2 credits for each Online Course (MOOC,SWAYAM,NPTEL) as that of other Self learning courses for UG and PG students.

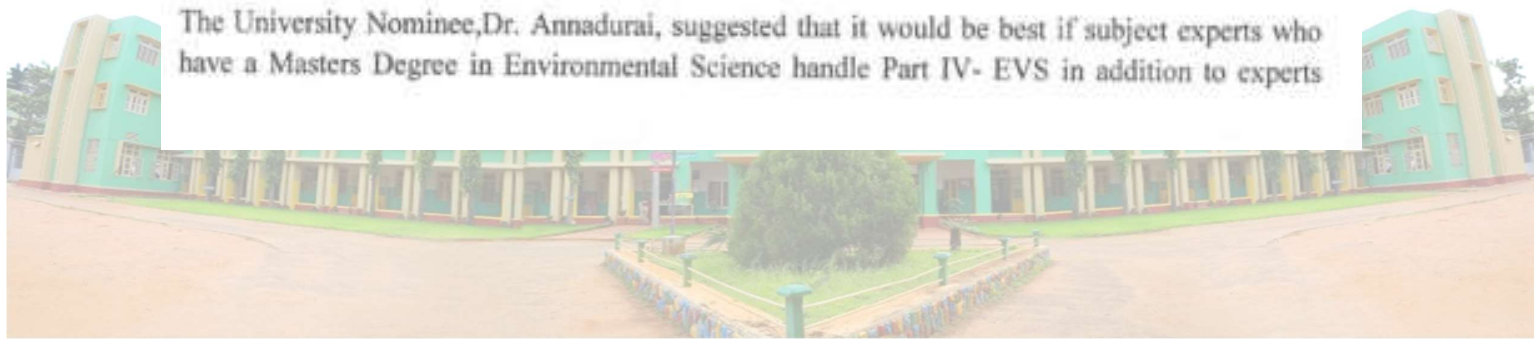
Two value added courses (Discipline-specific/ Interdisciplinary)are mandatory for all UG students whereas it is optional forPG students. Since certificates are provided for Value added courses from the organizations in collaboration with the college, the council suggested not to give credits for these courses.

**Item 13/AC 20.02/ 16: Revision of courses and study materials under Part IV and Part V**

The Dean of Science presented the revisions and recommendations for Part IV and Part V courses. The members of the council approved the changes in the course material for Environmental science.

Instead of Women's studies, it was proposed to have a course on 'Gender Equity Studies' in Part IV and to revise the course on 'Human Rights Education' including topics like Indian constitution – Preamble, Fundamental Rights, Fundamental Duties and Directive Principles of State Policy as one unit .

The University Nominee,Dr. Annadurai, suggested that it would be best if subject experts who have a Masters Degree in Environmental Science handle Part IV- EVS in addition to experts



from Botany, Zoology and Chemistry, as they would be well-versed in the subject and would be able to disseminate higher level of knowledge to the students. He also suggested that the college should think of starting a Department exclusively for Environmental Science, as an offshoot of Botany and Zoology.

**Item 14/AC 20.02/17: Regulations for Sports and other Activities during the Hour of Blossoming.**

It was resolved that, on the III & IV Day orders, the UG students from Science and Arts Departments will have their sports activities respectively. The staff in-charges from the respective departments will monitor the activities of the students.

**Item 15/AC 20.02/18: Attendance Regulations**

The Controller of Examinations presented the attendance regulations and the Academic council members resolved to accept the following regulations for students' attendance:

- i. The minimum attendance for the students for all programmes will be 75% as required by Manonmaniam Sundaranar University.
- ii. For Certificate Courses/ Value Added Courses/ Summer Training Programme and Field Work , a minimum of 85% is compulsory failing which the student has to repeat the programme to acquire the credit/ pass .

**Item 16/AC 20.02/19: New programme**

The Secretary of the College, Dr. Sr. Gerardin Jayam, proposed to start the Bachelors Programme in Business Administration (BBA), from the academic year, 2021-2022, since there is a demand for this programme. She also suggested that the college may not be able to retain B.Com S.F. Batch II, if the intake of students decreases in the forthcoming year.

**Item 17/AC 20.02/20: Suggestions and recommendations**

- i. Er. Edwin Jose, the Industrialist from Technopark, Trivandrum, suggested to conduct App Development workshops for Computer Science students in the 4<sup>th</sup> semester instead of conducting the same during the 3<sup>rd</sup> semester.
- ii. To overcome job crisis among out going students, the members of the council suggested to encourage entrepreneurial and startup culture among students. They can be trained in organic farming, Vermicomposting and Mushroom culture to begin with.
- iii. The student representatives suggested to include Martial Arts as part of the Certificate Courses as an initiative to encourage Women Empowerment.



**Item 18/AC 20.02/21:Next Academic Council meeting**

It was suggested to have the next Academic council meeting on 3rd September 2020.

**Concluding Remarks and adjournment of the Academic Council Meeting by the Principal**

The Principal thanked the Deans, Dr. Brisca Renuga and Dr. Alby Grace for their immense contribution and excellent co-operation during their tenure from 2017 to 2020. She then welcomed Dr. Jeni Chandar Padua, Dr. Virgin Nithya Veena and Dr. C. Sunitha who will be the Deans during the years 2020 to 2023. She also thanked all the retiring faculty especially Dr. Esther Leema Rose, Chair Person of the Department of English, and Dr. Mary Delphine, Chair Person of the Department of Physics, for their valuable contribution. She also thanked all the members of the Academic council for their co-operation and active involvement.

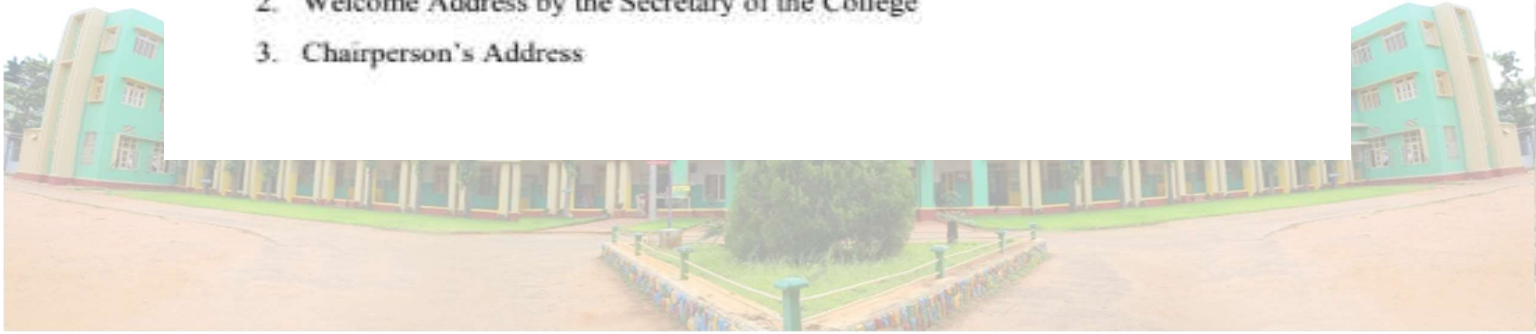

The meeting of the Academic Council commenced with prayer by Dr. S. Mary Mettilda Bai. The members of the Academic Council, the Heads of the Departments and Student Representatives, were present for the meeting. The Secretary of the College welcomed the members.

#### **Chairperson's Address**

The Principal, Dr. Sr. Anne Perpet Sophy, addressed the council and gave the reason for the conduct of this extra-ordinary Academic Council meeting which is to present the startup policy of the Institution Innovation Council, the key indicators for monitoring and evaluation of startups and to carry out the ratifications.

#### **Item 01/AC 20.11/ 04: Approval of the Minutes of the previous meeting**

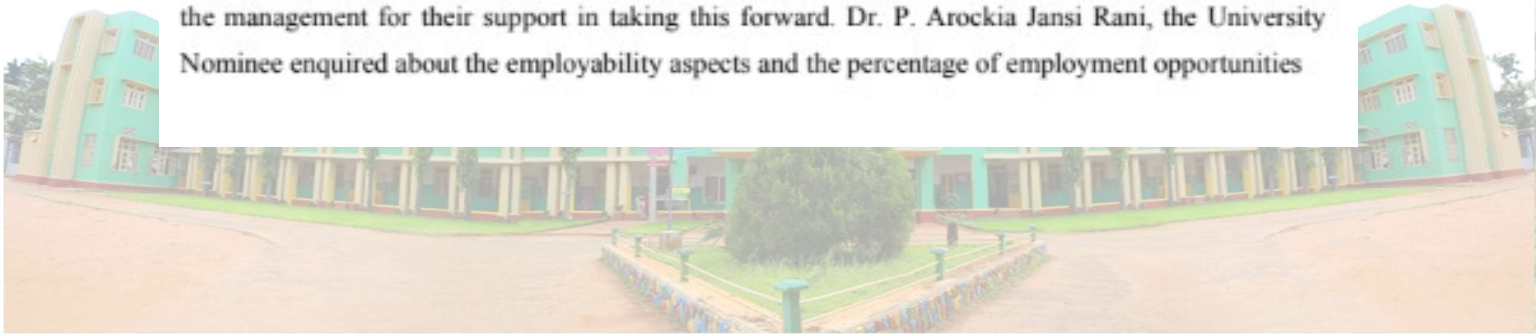
The Principal, Dr. Sr. Sophy, invited the Dean of Science, Dr. Jeni Chandar Padua to present the minutes of the previous meeting held on 25.02.2020. It was approved by the Council.

#### **Item 02/AC 20.11/ 05: Approval of the Report of the Action taken**

The Dean of Arts, Dr.V. Virgin Nithya Veena, presented the report of the action taken(Annexure 1). The Council members approved the report.

#### **Item 03/AC 20.11/ 06: Presentation of Startup Policy**

Dr. Sr. Sahaya Selvi, Vice-President of Institutional Innovation Council and NISP Co-ordinator presented the Startup Policy framed by the College (Annexure 2). She conveyed that these policies are instituted for achieving employability and financial empowerment of students. This is to be achieved by initiating a number of startups inside the campus in the next five years. She said Faculty Startups and Startups by Non-teaching Staff are also welcome. The University Nominee, Dr. V.S.Vasantha appreciated the efforts of the college in planning to bring about a startup ecosystem and congratulated the management for their support in taking this forward. Dr. P. Arockia Jansi Rani, the University Nominee enquired about the employability aspects and the percentage of employment opportunities



each startup would offer to students. She also requested that details regarding the same must be added to the policy statement for better clarity.

**Item 04/AC 20.11/ 07: Presentation of Key Indicators of the Startup Policy**

Dr. Jeni Chandar Padua, Dean of Science and Startup Co-ordinator of Institution Innovation Council, presented the Key Indicators of the Startup Policy aimed at planning, monitoring and evaluating the process of incubating Startups inside the campus (Annexure 3). She said this would help to plan on what we are going to achieve in 3 to 5 years from now and help to check whether the institution is on the right track to reach its goals. Accordingly, 100% Students & Faculty will be provided Orientation on Entrepreneurships. 15% of Students & Faculty will be motivated to start Entrepreneurial Activity. 5 Patents are planned to be filed and taken forward for commercialization. 20 Early Stage Students Start-ups are expected to come up. The final outcome expected is that Holy Cross College, Nagercoil, would become one of the best

Women's Innovation and Entrepreneurship Hub of the state, by 2025. The Startup Policy and Key Indicators were approved by the Council.

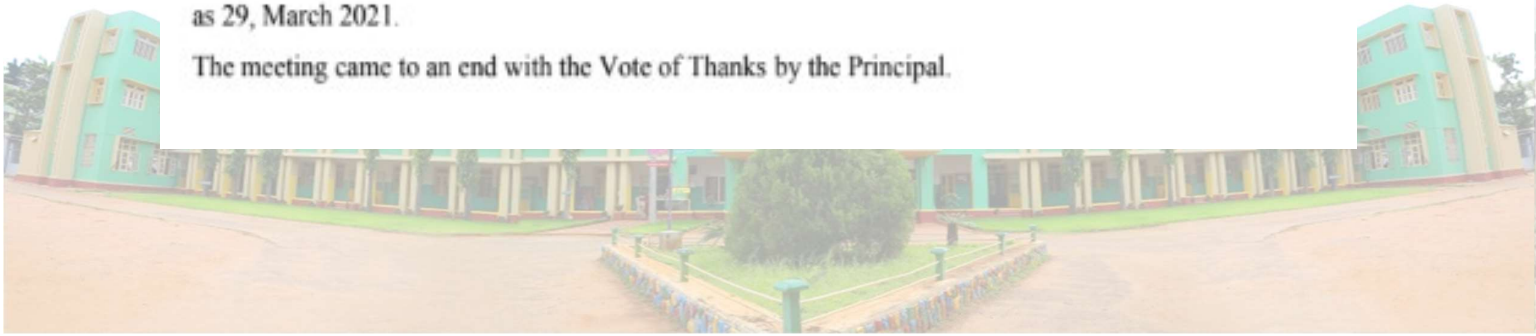
**Item 05/AC 20.11/ 08:** Dr. C. K. Sunitha, Dean of Commerce, presented the ratifications to be made (Annexure 4):

Regarding credit revision, query was made regarding the 5 hours and 4 credits for the project and core papers in the Department of Zoology. It was clarified by the Secretary that the department offers an extra paper and hence this adjustment. With this clarification, the ratification for credits revision presented in the council was approved.

It was explained how SWAYAM courses can be taken by the students and can earn extra credits. Dr. Arockia Jansi asked whether the institution has framed guidelines in adapting the online mode and explanation was given that the guidelines were formulated in the Staff Council on how to conduct examinations and classes via online mode.
